

First Time Home Buyers Tax Credit

In Canada the various levels of government provide a number of benefits to individuals purchase their first home. One credit I want to highlight is a Federal tax credit called the "First-time home buyer's tax credit". If you purchase a house for the first time this is credit and is worth \$750. There are a few restrictions for example you will not qualify if you or your spouse owned a how within the last 5 years. In order to receive this credit you have to file a personal tax return. The other credit I want to highlight today is the

are a few restrictions for example you will not qualify if you or your spouse owned a how within the last 5 years. In order to receive this credit you have to file a personal tax return. The other credit I want to highlight today is the Ontario Government's "Ontario Land Transfer Tax Refund" which is designed to compensate first-time home buyers for the Ontario Land Transfer Tax. To obtain this credit a special application needs to be filed with the province. Often this is done by your lawyer during the purchase process, but check to make sure your lawyer has applied for it on your behalf.

REAL ESTATE UPDATE

The November residential real estate market in Burlington saw and increase of 13.8 % in average sale price when

compared to the same month last year, according to MLS stats released by the Realtors Association of Hamilton-Burlington.

For the residential market overall, number of listings were down slightly by 3.2% over last year, and the number of sales were virtually the same.

Residential homes increased by 1.9% in number of sales, and 15.4% in sale price over November of 2010. Condominiums saw a small 2.6% decrease in the number of units sold, but the price did increase by a substantial 5.9% from November of last year.

TD Canada Trust Economic Quarterly Forecast

Canada may boast a number of comparative economic strengths, but its fortunes as a

small economy will remain closely tied to developments abroad. In this vein, prospects for anemic growth in the United States, Europe's ongoing debt crisis and continued financial market jitters are likely significantly constrain Canada's rate of expansion over the next several guarters.

In our revised timetable, the Bank of Canada's overnight rate it expected to hold at 1.00% until early 2012 – some 12 months later than projected in June. This continued low interest rate environment will continue to provide support to housing activity and purchases. In June, a central theme was a likely shift in the drivers of overall growth from fatigued households & governments to business investments & exports, especially as the U.S. economy recovered. However, business confidence has been weakened by the external risks & the strength of exports are now in question, implying that the transition in drivers of economic growth has been delayed.

Following the completion of construction between Appleby Line and Walkers Line, Burlington Transit has extended service to Alton Village across Thomas Alton Blvd.

Norton Park Construction Update

Norton Community Park is located at the north-east corner of Dundas St. and Tim Dobbie Dr. It's an active construction site with the skate park, artificial turf fields and 3 concrete seat walls all finished. The park Pavilion with washrooms



and splash pad are approximately 50% complete. Most of the park will be completed by end of 2011. While some will be complete, it will not be ready until the entire park is officially opened. Park is scheduled to open in Spring 2012.
